First option would be to move graduation date to June 12<sup>th</sup> & follow social distance guidelines with limitations of how many can be allowed inside the facilities & the 2<sup>nd</sup> option would be to have graduation sometime in July. Also discussed having multiple ceremonies at Dresden High School & Westview High School since they have more students to graduate. Will be discussing the best option with the principals, nurses and Coordinated School Health personnel after all end of year topics and hoping to have livestream graduation ceremonies weekend of June 12<sup>th</sup>.
- XI. Discuss Summer Activities Mr. Frazier explained to the board about the upcoming Zoom meeting with other superintendents, TSSAA Staff and medical experts on getting guidance on how the schools can move forward to opening up their facilities for practices & training. He did mention the facilities will be closed at least up thru the end of May & then they will hopefully have a better plan of moving forward to opening up. There will not be any summer school classes during this summer and we will have a plan on how to make this up when we get closer to returning back to school in the fall.
